Recognition of Prior Learning (RPL) Fees

RPL means an assessment process that assesses the competency/s of an individual that may have been acquired through formal, non-formal and informal learning to determine the extent to which that individual meets the requirements specified in the training package or VET accredited courses. If a Learner declares and can satisfactorily demonstrate before the commencement of an enrolled unit, that they have had relevant formal and informal training, RPL may be appropriately applied

RPL Application fee of \$400 for each program will be charged at the time of application and is non-refundable.

The RPL fee will be charged at a rate of \$2.00 per nominal hour for each unit of competency that RPL has been requested.

There is no fee charged for National Recognition (Credit Transfer).
